Q Highlights

The **S&P Healthcare Services** Index increased 1.0% over the last month, outperforming the S&P 500, which increased 0.9% over the same period.

Over the past month:

The best performing sectors were Diagnostic Imaging (up 9.5%), Consumer Directed Health and Wellness (up 8.1%), and Managed Care -Commercial (up 6.2%).

The poorest performing sectors were Physician Practice Management (down 13.1%), Pharmacy Management (down 7.3%) and Healthcare Staffing (down 6.0%).

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.39x and 13.5x, respectively.


