

Health Care Sector Update

January 2013

Summary – Health Care Services

- The S&P Health Care Services Index has declined 3.0% over the last three months, underperforming the S&P 500.
- · Over the last three months:
 - > The best-performing sectors were Contract Research Organizations (up 16.0%) and Managed Care – Government (up 10.6%).
 - > The worst-performing sectors were Emergency Services (down 11.3%) and Diagnostic Imaging (down 8.8%).

- The current median LTM revenue and LTM EBITDA multiples for the Health Care Services industry overall are 1.2x and 8.6x, respectively.
- The sectors with the highest valuation multiples include:
 - > Specialty HCIT (2.4x LTM Revenue, 25.4x LTM EBITDA)
 - > Provider-Based HCIT (3.0x LTM Revenue, 13.5x LTM EBITDA)

Pharmaceutical / Medical Devices / Life Sciences

- The S&P 500 Pharmaceuticals, Biotechnology & Life Sciences Index has declined 0.8% over the last three months, performing better than the S&P 500.
- · Over the past three months:
 - > The best performing sector was Dental Devices (up 5.2%).
- > The worst performing sector was Cardiology Devices (down 9.2%).

- The current median LTM revenue and LTM EBITDA multiples for the Pharmaceutical / Medical Device / Life Science industry overall are 2.1x and 10.7x, respectively.
- The sectors with the highest valuation multiples include:
- > Biotechnology (4.1x LTM Revenue, 11.3x LTM EBITDA)
- > Surgical Devices (1.5x LTM Revenue, 19.3x LTM EBITDA)

M&A Activity - Health Care Services

M&A Overview

The last twelve months ("LTM") M&A volume in the Health Care Services sector has shown a monthly decline since February 2012. The deal volume has declined by 26.3% Y-o-Y to 392 deals. Deal volume has declined by 25.4% Y-o-Y to 91 deals for the three months ended December 2012. The proportion of announced deals made by financial buyers has increased to 6.6% during the LTM as compared to 5.3% for the same time period last year.

Exhibit 1: Transaction Activity






Exhibit 2: Monthly Transaction Volume - Rolling LTM



M&A Activity by Health Care Services Industry Sector

Home care / Hospice / Long-term Care / Assisted Living and Care Management / TPA have accounted for 14% and 12%, respectively, of activity by number of deals in the last twelve months and collectively they represent the two most active health care services sectors.

Notable Transactions in the Last Three Months

Sun Healthcare Group Inc.

On December 3, Sun Healthcare Group sold National Hospice Holdings, LLC to Solamor Hospice, Inc. for \$85 million and concurrently Genesis HealthCare LLC closed its strategic acquisition of Sun Healthcare Group for \$275 million, representing a 0.1x and 3.4x revenue and EBITDA multiple, respectively, to Sun Healthcare's March 2012 LTM revenues and EBITDA of approximately \$1,922 million and \$80 million. Sun Healthcare provides health care services for the senior population in the U.S. and operates skilled nursing centers and assisted living centers as well as offers rehab and therapy services. The transaction was announced on June 20.

AMERIGROUP Corporation

On December 24, WellPoint closed its \$5.1 billion strategic acquisition of AMERIGROUP Corporation, representing a 0.6x and 15.7x revenue and EBITDA multiple, respectively, to AMERIGROUP's June 2012 LTM revenues and EBITDA of approximately \$7.2 billion and \$286 million. AMERIGROUP operates as a multi-state managed health care company focused primarily on Medicare, Medicaid and Children's Health Insurance Program. The transaction was announced on July 9, 2012 and as of September 30, 2012, AMERIGROUP had LTM revenues and EBITDA of \$8.1 billion and \$276 million, respectively.

Metropolitan Health Networks

On December 21, Humana Inc. closed its \$796 million strategic acquisition of Metropolitan Health Networks, Inc., representing a 1.0x and 7.7x revenue and EBITDA multiple, respectively, to Metropolitan's September 2012 LTM revenue and EBITDA of \$755 million and \$96 million. Metropolitan Health Networks operates a provider services network in Florida through 33 wholly-owned primary care practices primarily for Medicare and Medicaid beneficiaries. The transaction was announced on November 5.

Reach Medical Holdings

On December 5, Air Medical Group Holdings (backed by Bain Capital) closed its strategic acquisition of Reach Medical Holdings for \$240 million in cash, of which \$40 million is payable if Reach receives certain reimbursements under the Emergency Medical Air Transportation Act of the State of California. Reach Medical Holdings Inc. provides helicopter and airplane ambulance services to critically ill and injured patients. This acquisition broadens the reach of Air Medical Group to Southern Texas, Oregon and California. The transaction was announced on November 11 and closed on December 5.





Exhibit 1: Transaction Activity







Exhibit 2: Rolling LTM - Transaction Volume





Exhibit 1: Transaction Activity







Exhibit 2: Rolling LTM - Transaction Volume
