The S&P Healthcare Services Index has increased 1.3% over the last month, outperforming the S&P 500, which did not change over the same period.

Over the past month:

- The best performing sectors were Managed Care Government (up 11.5%), Healthcare REITs (up 8.6%) and Other Services (up 6.5%)
- The poorest performing sectors were Assisted / Independent Living (down 11.4%), Emergency Services (down 7.6%) and Contract Research Orgs (down 3.8%)

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.34x and 14.2x, respectively.

The sectors with the highest valuation multiples include:

- HCIT (4.67x LTM Revenue, 27.0x LTM EBITDA)
- Pharmacy Management (1.14x LTM Revenue, 26.7x LTM EBITDA)
- Other Services (2.08x LTM Revenue, 22.8x LTM EBITDA)
- Healthcare REITs (14.01x LTM Revenue, 22.0x LTM EBITDA)






Performance of Market Indices for Latest 36 Months
