The S&P Healthcare Services Index has increased 7.2% over the last month, outperforming the S&P 500, which increased 0.1% over the same period.

Over the past month:

- The best performing sectors were Assisted / Independent Living (up 17.9%), Emergency Services (up 12.6%) and Psychiatric Hospitals (up 11.2%)
- The poorest performing sectors were Other Services (down 17.1%), Managed
 Care Government (down 4.6%) and Care Management / TPA (down 2.9%)

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.37x and 14.2x, respectively.

The sectors with the highest valuation multiples include:

- HCIT (3.38x LTM Revenue, 28.3x LTM EBITDA)
- Pharmacy Management (1.07x LTM Revenue, 28.0x LTM EBITDA)
- Healthcare REITs (13.24x LTM Revenue, 20.5x LTM EBITDA)
- Clinical Laboratories (6.38x LTM Revenue, 18.0x LTM EBITDA)



Performance of Market Indices for Latest 36 Months




Average % Change — 1 Month
