Healthcare Services Sector Update

May 2018



Q Highlights

The **S&P Healthcare Services** Index increased 3.7% over the last month, outperforming the S&P 500, which increased 2.2% over the same period.

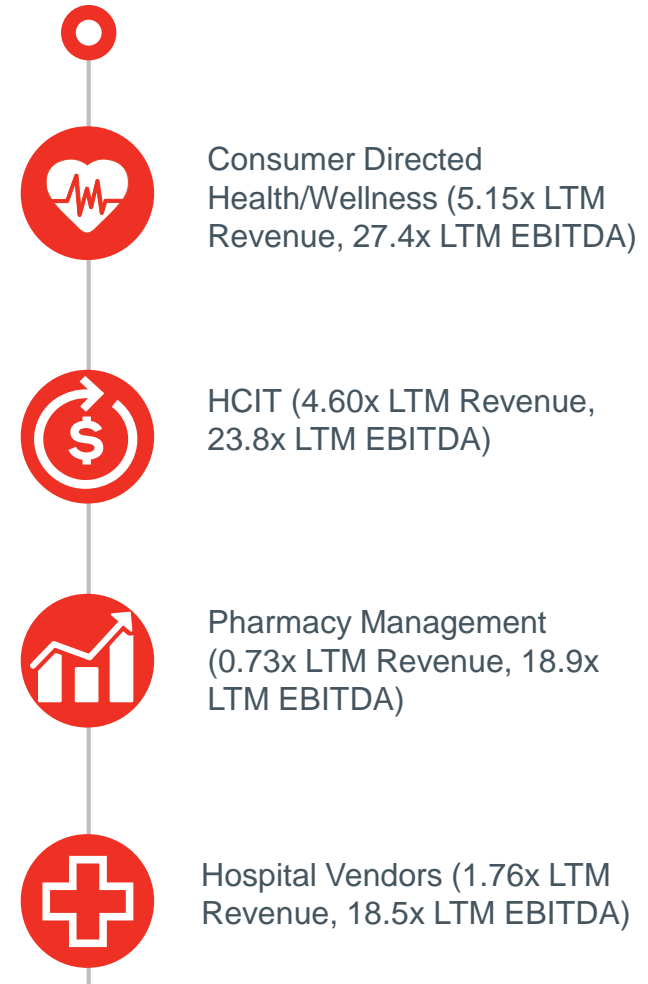
Over the past month:

The best performing sectors were Skilled Nursing (up 24.0%), Healthcare Consulting (up 11.4%) and Behavioral Health (up 10.7%).

The poorest performing sectors were Healthcare Staffing (down 13.7%), Distribution (down 11.1%) and Care Management/TPA (down 1.7%).

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.22x and 14.3x, respectively.

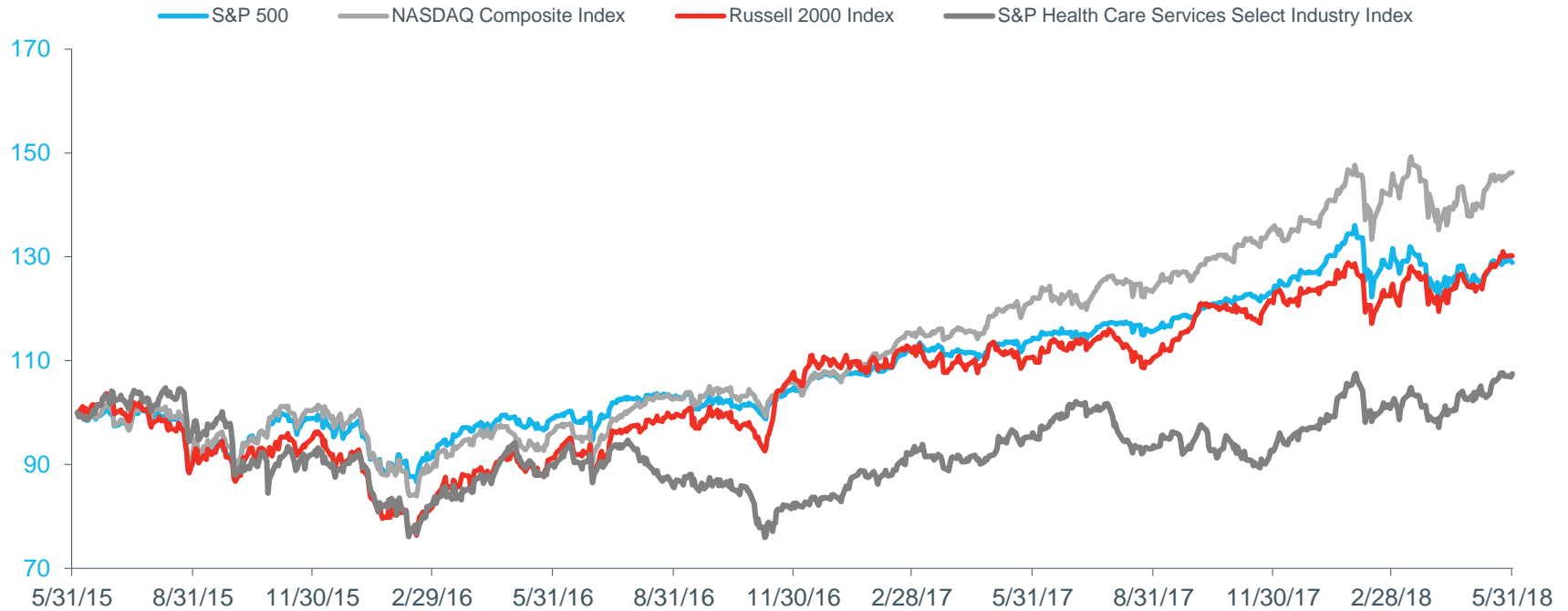

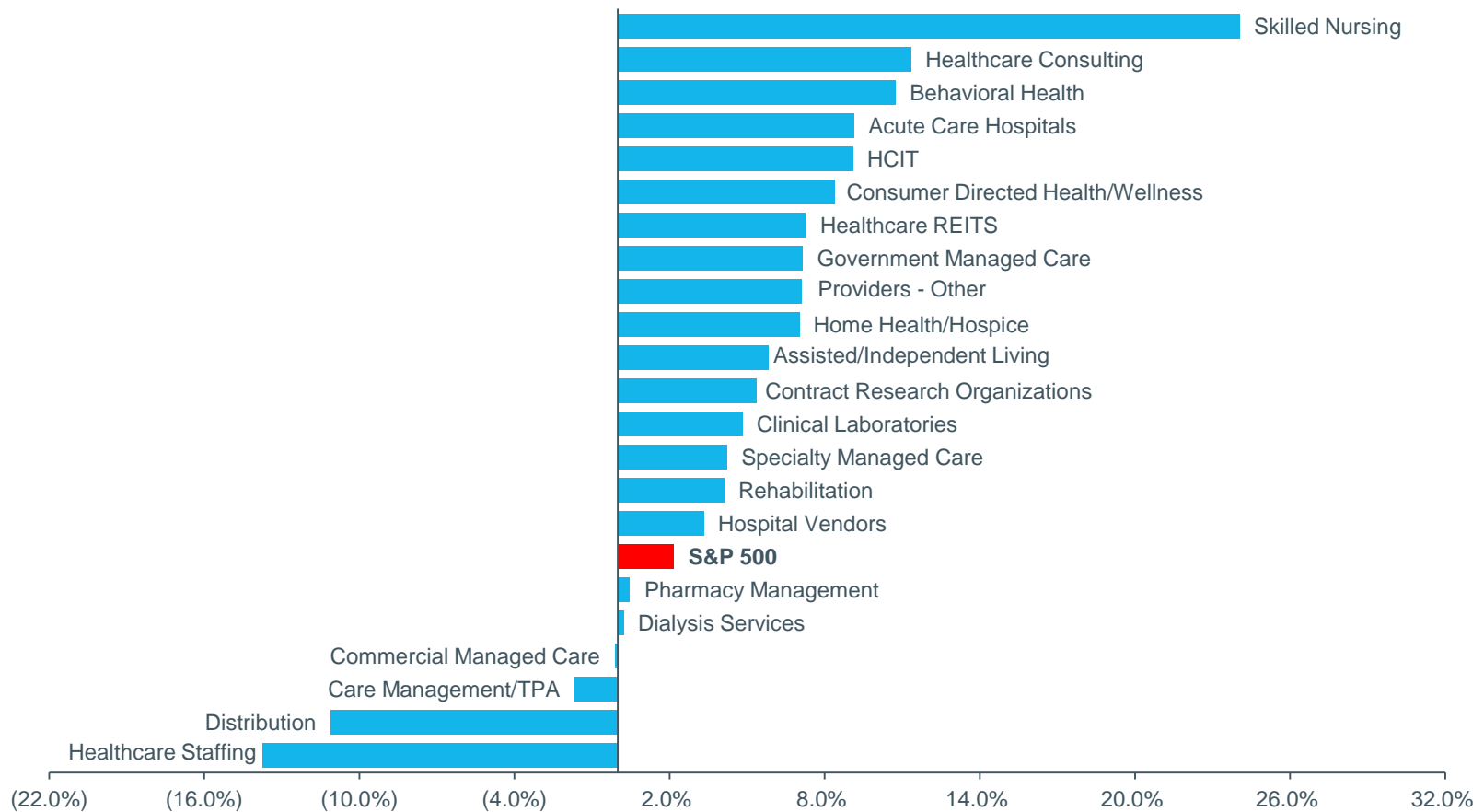

Healthcare Services Sector Change

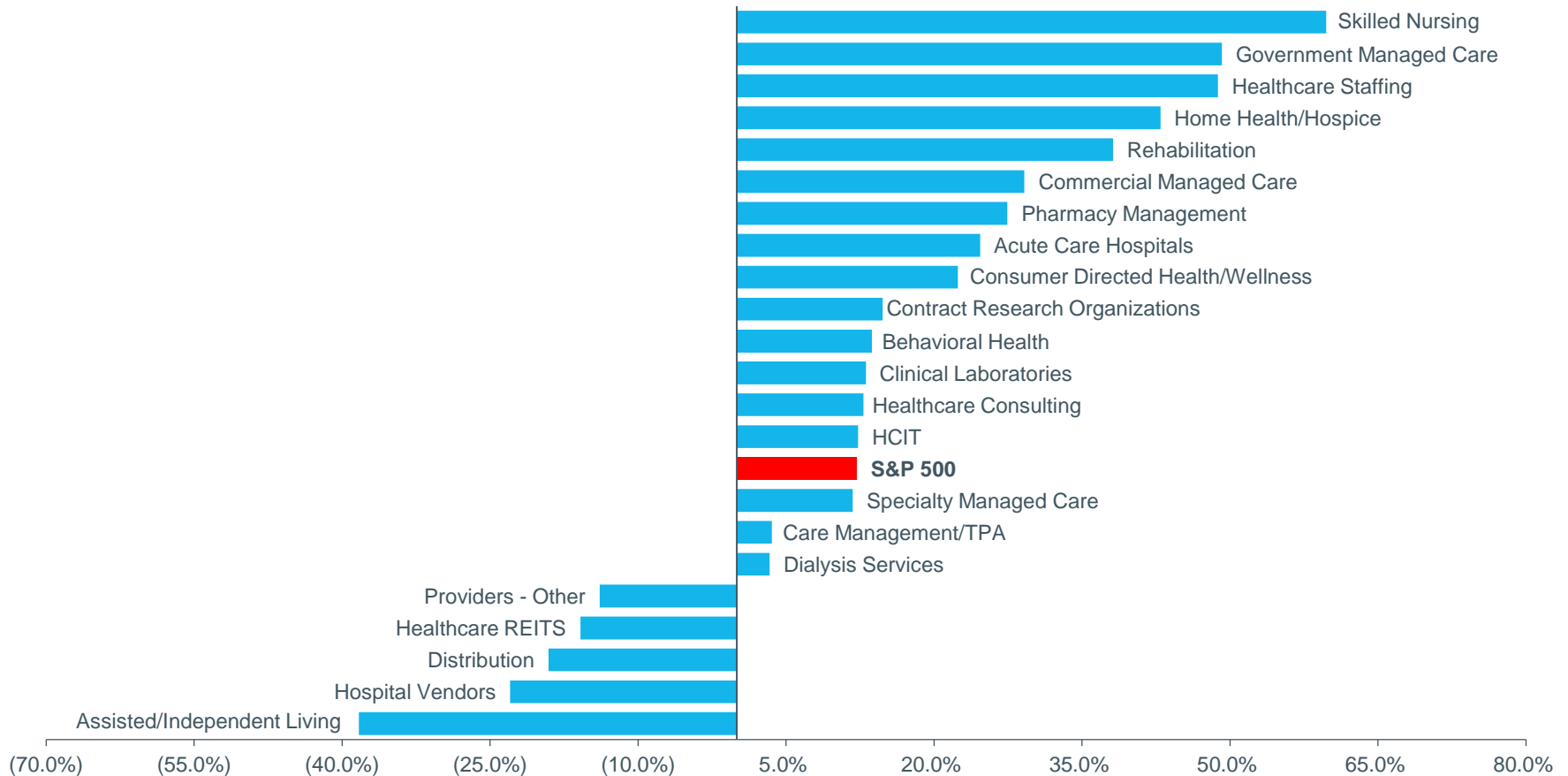
Average % - 1 Month Change

Healthcare Services Sector Change

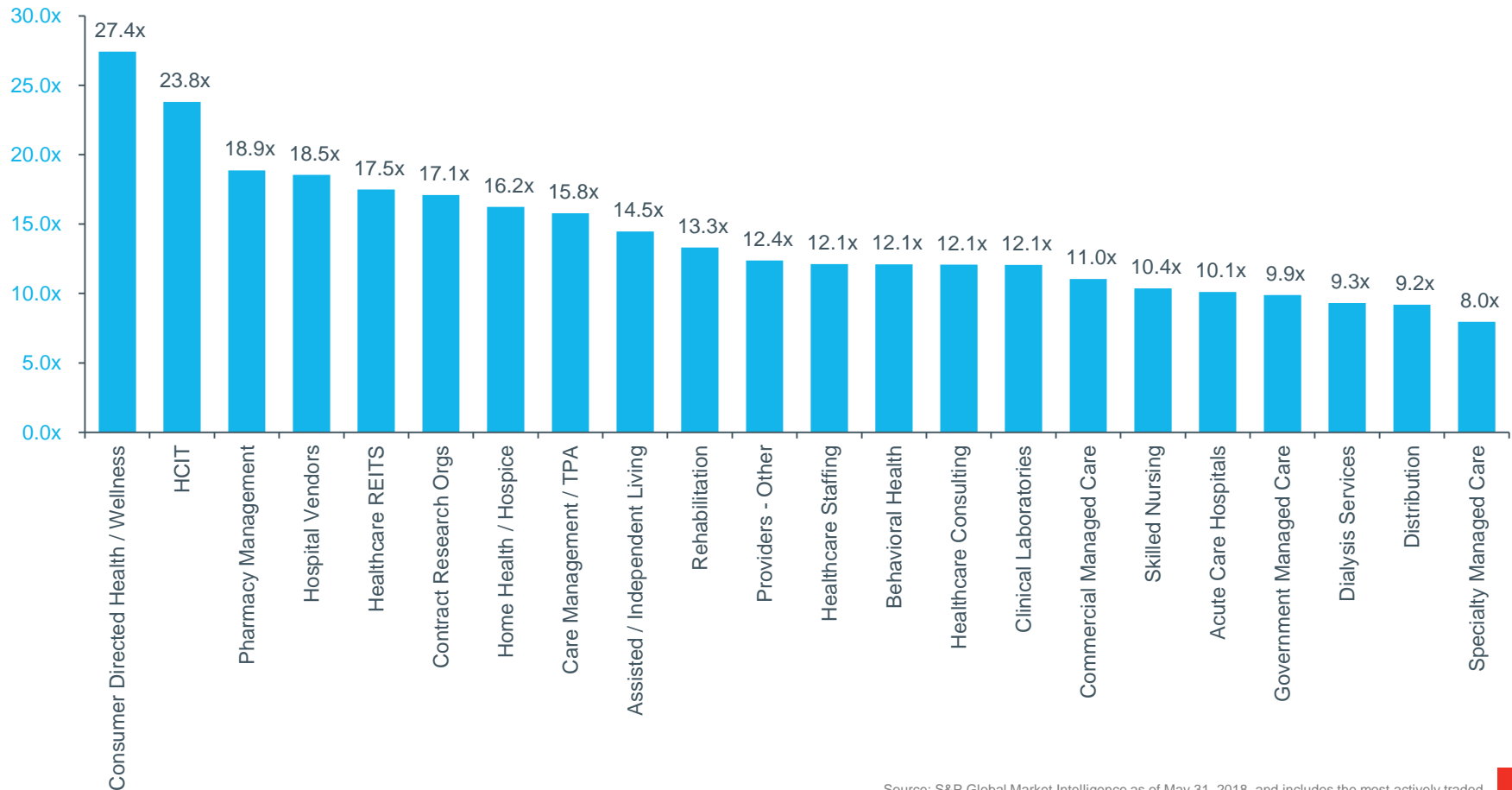
Average % - 12 Month Change
