Q Highlights


The **S&P Healthcare Services** Index increased 0.9% over the last month, in line with the S&P 500, which increased 1.0% over the same period.

Over the past month:

The best performing sectors were Pharmacy Management (up 14.4%), Dialysis Services (up 9.4%), and Providers – Other (up 8.4%).

The poorest performing sectors were Assisted / Independent Living (down 10.4%), Skilled Nursing (down 7.6%) and Consumer Directed Health / Wellness (down 6.6%).

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.26x and 14.4x, respectively.








Healthcare Services Sector Change ..
