

Q Highlights

The **S&P Healthcare Services**Index increased 5.3% over the last month, outperforming the S&P 500, which increased 1.8% over the same period.


Over the past month:

The best performing sectors were Assisted / Independent Living (up 17.5%), HCIT (up 10.8%) and Emergency Services (up 10.6%).

The poorest performing sectors were Skilled Nursing (down 6.3%), Diagnostic Imaging (down 4.3%) and Dialysis Services (down 3.4%).

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.34x and 13.2x, respectively.




