Q Highlights

The **S&P Healthcare Services** Index increased 1.0% over the last month, underperforming the S&P 500, which increased 1.9% over the same period.

Over the past month:

The best performing sectors were Consumer Directed Health and Wellness (up 15.8%), Care Management / TPA (up 9.0%), and Managed Care – Government (up 8.7%).

The poorest performing sectors were Assisted Living / Independent Living (down 6.5%), Clinical Laboratories (down 6.3%) and Healthcare REITs (down 2.9%).

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.54x and 15.7x, respectively.


Performance of Market Indices for Latest 36 Months






