The S&P Healthcare Services Index has increased 1.3% over the last month, underperforming the S&P 500, which increased 1.5% over the same period.

Over the past month:

- The best performing sectors were Healthcare Staffing (up 10.6%), Care Management/TPA (up 7.7%) and Distribution/Supply (up 3.2%)
- The worst performing sectors were Skilled Nursing (down 13.0%), Psychiatric Hospitals (down 5.9%) and Surgicenters/Rehabilitation (down 5.0%)

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.30x and 14.0x, respectively.

The sectors with the highest valuation multiples include:

- HCIT (3.44x LTM Revenue, 26.9x LTM EBITDA)
- Pharmacy Management (1.09x LTM Revenue, 24.2x LTM EBITDA)
- Healthcare REITs (13.21x LTM Revenue, 20.7x LTM EBITDA)
- Consumer Directed Health and Wellness (3.60x LTM Revenue, 20.0x LTM EBITDA)



Performance of Market Indices for Latest 36 Months




Average % Change — 1 Month
